Pick up of artwork*: After reception OR on November 13 between 10:00 a.m. and 4:00 p.m.

*Works in show must be picked up at time stated and may not be removed from the show until then.

Entry Procedures

- Judging of entries will be done from the electronic high resolution file of at least 300 dpi delivered via email. See back panel for entry instructions
- Submit one JPEG image for each 2D artwork. **Each file must be no larger than 2 megabytes.**
- For 3D craft and sculpture, you may submit up to three JPEGs (front, back, and side views), if you wish. **Each file must be no larger than 2 megabytes.**

Entry Criteria

- There is a \$5 entry fee for each accepted piece.
- Work must be original (i.e., not copied from another work of art or published source), and must have been completed within last three years.
- Printed reproductions or computer-generated art will not be accepted.
- All 2D work must be dry and wired for hanging using secure attachments. Saw tooth hangers not allowed.
- 3D work must be delivered with a pedestal or be free standing.
- Dimensions: 2D work no wider than 36 inches.



SALES are encouraged and promoted. Although artists may choose to give more, at least a 15% commission is to be donated to LGNC by December 2, 2017. Artwork sold during the show must remain on display until the end of the show.

RELEASE Although artists retain copyrights to their artwork, by entering this exhibition, please understand that LGNC may use images of your artwork on its website, social media, or other publications for educational and promotional purposes (with credit to the artist whenever possible). **If you wish to refuse the publication of such images**, please indicate as such when submitting entries via email.

Liability

Lehigh Gap Nature Center or anyone helping with the exhibition is not responsible for damage or loss during delivery, handling and pickup, or exhibition. Utmost care will be taken to protect artworks. By entering this exhibition you acknowledge that you agree to this release clause and will not hold Lehigh Gap Nature Center responsible, which includes any art work not picked up at the designated time at the close of the exhibition.

All reasonable care and security measures (alarm system, on site caretaker) will be taken in handling and displaying works.
