\*Works in show must be picked up at time stated and may not be removed from the show until then.

## Entry Procedures

- Judging of entries will be done from an electronic high resolution file of at least 240 dpi delivered via email (not more than 20 MB file). See back panel for entry instructions.
- Submit up to three (3) entries.

## Entry Criteria

Entries must be original works of the photographer taken in the past five years. Photographs must have been taken in PA or surrounding states. Images should be standard color or black-and-white toned. High Dynamic Range (HDR) photos are acceptable, but otherwise, no digitally enhanced/manipulated (unnatural) photos, composites, etc. will be accepted. Photographs may not feature captive or baited wildlife. Up to ninety (90) photographs will be accepted in the show. Entries from those 16 years old or under will be judged in "Youth" category.

## Accepted Entries

- There is a \$5 entry fee for each accepted photograph.
- Photographs must be printed, mounted, and wired for hanging using secure attachments for framed or canvas wrapped images, or with velcro hook for foam core mounts.
- Prints must be high-resolution (i.e., no pixelation), or they will not be accepted.
- Maximum dimensions, **including framing:** max height 30 inches, max width 34 inches

**SALES** are encouraged and promoted. Although photographers may choose to give more, at least a 15% commission is to be donated to LGNC by April 14, 2018. Mounted photographs sold during the show must remain on display until the end of the show. Prints of photographs may be sold separately by the photographer.

**RELEASE** Although photographers retain copyrights to their photographs, by entering this exhibition, please understand that LGNC may use your image(s) on its website, social media, or other publications for educational and promotional purposes (with credit to the photographer whenever possible). **If you wish to refuse the publication of such images**, please indicate as such when submitting entries via email.

Lehigh Gap Nature Center (LGNC) or anyone helping with the exhibition is not responsible for damage or loss during delivery, handling and pickup, or exhibition. Utmost care will be taken to protect photos.
